<u>On Saturday, February 9th</u>, the Book Group will sponsor a talk, "Women as Leaders: Four Local

Activists", at the TCPL Borg Warner Room at 10:30 a.m. This will be a panel discussion with Liddy Bargar, longtime director of the Samaritan Center of Catholic Charities of Tompkins/Tioga; Anna Gardner, president of Ithaca College Feminists United; Tatiana Jorio, president of Ithaca College Planned Parenthood Generation Action; and Tracy Mitrano, educator, lawyer, and 2018 political candidate. Our book group has been reading the book, *Make Trouble*, a memoir by Cecile Richards, which talks about standing up, speaking out and finding the courage to lead.

<u>On March 16th</u>, Sophia Elie, who is an AAUW fellow, will tell us about her AAUW Fellowship and what this support has meant to her. We will meet at the Alice Cook House on west campus in the seminar room at 10:30 a.m.

Our special treat on <u>Tuesday, April 9th</u> is a dynamic talk by Elaine Engst, Cornell University archivist (retired), and Carol Kammen, the Tompkins County Historian. They will speak about *Achieving Beulah Land*. This is a history of women's suffrage activities in Tompkins County from the 19th century to just after World War I. They have written a book by the same title. What I have found really fascinating is the role that several of the founding mothers of the Ithaca branch of AAUW had in the suffrage movement. We will co-sponsor this talk with the TCPL and it will be held at the Borg Warner Room of the TCPL at 7 p.m.

Stay tuned for more info in the next newsletter about our May dinner. Hope to see you at our programs this spring.

# Make Trouble

Whether or not you can come to our program at the library this Saturday, do read Cecile Richards' book, *Make Trouble: Standing Up, Speaking Out, and Finding the Courage to Lead.* She speaks honestly and movingly about a life of standing up for justice and fairness. As a student she sided with the striking janitors. As a union organizer she worked to get nursing home workers living wages. As a parent she worked to keep accurate history and science in children's textbooks.



Her mother, Ann Richards, was the first and only woman to be elected governor of Texas. She quotes her mother, who said that politics "is a contest of wills between folks who are satisfied with how things are and those who are passionate about what could be better. . . .[between those] desperate to hang on to power and those who wanted to widen the circle of opportunity for all Texans."

Cecile Richards advises us to have fun and make friends while we fight uphill battles because we are going to lose more than we win. "If it was easy," she says, "someone else would be doing it."

# LAF SUPPORTS DR. NATHALIE GOSSET DEFENDING TITLE VII



For over 40 years the Legal Advocacy Fund has been involved with pay inequity cases, sexual harassment and rape cases, and both Title VII and Title IX compliance violations. LAF has supported women financially and provided legal counsel to women who have been discriminated against at academic institutions and at corporations. In addition, many AAUW members have provided emotional support to these women.

In September 2016, the Legal Advocacy Fund committee adopted the case of AAUW member Dr. Nathalie Gosset while it was in the arbitration phase. The case was brought against the executive director of the Alfred Mann Institute at the University of Southern California, the Head of Human Resources, and the University of Southern California for violating Title VII of the Civil Rights Act of 1964 for wrongful termination. Title VII protects employees from sexual harassment and forbids

employers from retaliating against their employees for filing a charge of harassment or speaking out against harassment.

Dr. Gosset worked as an engineer for over 30 years and was hired by the Alfred E. Mann Institute in 2003 as a senior engineering manager. She was promoted to senior director of marketing and technology innovation evaluation, a position directly below the executive director of the Alfred E. Mann Institute. In 2007, after Jonathan Lasch was hired as the executive director of the institute, Dr. Gosset reported several times to Human Resources at the University that she had been repeatedly sexually harassed and threatened by the him. Human Resources failed

to investigate the complaints. In February 2015, during a human resources meeting regarding the reported incidents, Jonathan Lasch stated "that he could not guarantee that he would be able to contain his sexually bullying behavior because the bully was in his blood." The institute became an increasingly hostile environment; work-related reprimands were issued. In October, 2015, Dr. Gosset's employment was terminated.

Nathalie Gosset's case is scheduled to be heard in court this year based on the university failure to follow its written policies on investigating sexual harassment claims within 60 days. Her attorney, Lisa Bloom, hopes for a multi-million dollar settlement based on lost earnings and benefits, including Dr. Gosset's daughter's full four-year scholarship awarded by the university through its tuition exchange program.

Over the course of her career, Dr. Gosset had been an active leader with California's Tech Trek Program, which offers middle school girls a week on college campuses exploring STEM academic majors and careers. Her work has encouraged more girls and women to pursue careers in STEM.
