THE 2-MINUTE ACTIVIST

AAUW provides all the tools you need to send emails and texts to your state legislators and members of Congress. You can contact them about pressing issues to fight for equal pay, family leave, stopping sexual harassment, equality in education and more. When the New York State Legislature and the Congress are in regular session in the fall, AAUW National will send emails on issues of public interest. A letter is already formulated for you. All you have to do is click on the legislator's name and send that letter. It is a simple process and an easy and effective way to be a part of getting legislation for women passed.

All you need to do is sign up, however, AAUW's website can be confusing to its members. I have broken down the steps to help members register for this valuable tool.

Steps to Register for 2-Minute Activist

- 1. Go to AAUW.org on a computer or phone with internet capability
- 2. Click on the magnifying glass
- 3. Type in 2-Minute Activist
- 4. Go to the bottom of the page and clik on sign-up
- 5. Put in member's contact information
- 6. Tap submit

The following is a statement from Kate Nielson, AAUW's Senior Director of Public Policy, Legal Advocacy, & Research:



"AAUW strongly condemns the U.S. Supreme Court's refusal to suspend implementation of a dangerous Texas law that would virtually strip individuals of their well-established, Constitutional right to control their bodies and erode their economic security. The nation's highest court is enabling a

vicious system of vigilante lawsuits that aims to turn citizens against one another in furtherance of the most extreme anti-choice agenda. This ruling, which bypasses Constitutional review, effectively abolishes a pregnant person's ability to make personal choices. Curtailing reproductive rights is a seismic affront to all Americans and AAUW vows to ferociously fight to ensure quality, affordable, and accessible health care for all."


